WILDLIFE TOMORROW AGREEMENT

This agreement made this _____ day of _____, 20____ between:

SASKATCHEWAN WILDLIFE FEDERATION
(the "Federation")

- and -

(the "Landowner")

WHEREAS Saskatchewan Wildlife Federation operates the "Wildlife Tomorrow" program, a private stewardship program wherein lands allocated to the said program by Landowners are retained in the program for the purpose of providing habitat for wildlife; and

WHEREAS the parties hereto have agreed to set aside certain lands as more fully described herein;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT;

1. The Landowner hereby allocates the lands described below, to be held in their natural state, for the purposes of wildlife habitat. Further, the Landowner retains full ownership and control of land use and access, but agrees not to burn, clear or drain said lands. Minimal grazing is permitted.

2. The Federation will accept these lands into the Wildlife Tomorrow program and agrees to post the lands for the purposes described and in the manner detailed in the explanatory brochures and information provided to the Landowner with respect to the said program.
3. The parties acknowledge that the lands allocated to the Wildlife Tomorrow program and the information required to properly acknowledge the donor are described as follows:
